Rating Rationale

Acuite has reviewed the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A4**) on the Rs. 11.50 crore bank facilities of Satkartar Electronics (SE). The ratings are now indicative ratings and are based on best available information

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

SE was established as proprietorship concern in 1960 by Mr. Kuldeep Singh. The firm executes tender based electrical contracts awarded by government department and private institutions in Delhi, Uttar Pradesh, Haryana and among Others.

For FY2014-15, SE reported profit after tax (PAT) of Rs. 0.58 crore on operating income of Rs.19.96 crore, as compared with PAT of Rs. 0.58 crore on operating income of Rs.18.13 crore in FY2013-14.
